New Jersey Early Intervention Week May 15-22, 2011

New Jersey Early Intervention Week was created to recognize that all children have special and unique gifts that deserve the care and attention of their families and communities. The state also recognizes how the New Jersey Early Intervention System (NJEIS) plays an essential role in supporting families to ensure that all infants and toddlers have the opportunity to develop, grow and ultimately lead productive lives in the community. In that spirit, participants are asked to compose an essay outlining: “***What I’ve Learned About My Child and Family during our time in Early Intervention***” Essays should describe the following points:

- Describe what has been the most rewarding experience for your child and family as a part of the New Jersey Early Intervention System
- What strategies have you learned that have helped your child’s development and you as a parent
- How has a New Jersey Service Coordinator and/or an NJEIS Provider supported your family

Essays must contain approximately 250 and 500 words. Only **one** entry per household. Essays must include the experiences of a child and family that have received NJEIS services within the past 12 months (**January 1, 2010 to present**). Each entry must be submitted with a registration form (available via email or on our website) detailing the author’s name, address, telephone number, New Jersey Early Intervention Service Coordinator, New Jersey Early Intervention Provider Agency or agencies and month and year of when services began. **Submissions sent without this information will not be eligible. FAMILY LINK Essay Contest Eligibility and Entry Rules

Participants must be a New Jersey resident living in the Family Link region (Essex, Morris, Union, Sussex and Warren Counties), and have a child that has received New Jersey Early Intervention Services within the past 12 months (**January 1, 2010 to present**).

Employees of the Department of Health and Senior Services, the four Regional Collaboratives and its Board of Trustees, Single Point of Entry Service Coordination Units, County Special Child Health Service Coordination Units and Regional Service Provider Agencies and their immediate families are not eligible for this contest.

All entries must be in Family Link's office by 5 pm on Friday, **May 6, 2011**.
Submissions sent via email must have a registration form attached to the email.

Family Link Prizes

Gift Certificates in the following amounts are to be awarded to two winning essays.

- Grand Prize: \$75 Toys-R-Us
- First Prize: \$25 Toys-R-Us

All entrants will receive a Certificate of Participation and winners will be notified via email and/or mail by **Friday, June 3, 2011**.
